Submittal for Testing and Approval

A. Scope

Before materials can be used for a Department project, the manufacturer/supplier must have a producer/supplier number assigned to their facility. The following guidelines are provided to clarify the submittal requirements and expedite the process.

B. Procedure

When requesting producer/supplier status with the Department, the following shall be included in the certification:

- Manufacturer name and internet address (if applicable),
- The specific product brand name, (if private label must provide original product name)
- Material Safety Data Sheet (if applicable),
- Technical Data Sheet,
- A signed letter stating the subject material will not be changed without written notification to the Department, and
- Contact person's name, title, address, email address, and phone number.
- Acknowledgment by Company (Form <u>BMPR 101</u>). If your company does not already have a
 product included on an IDOT QPL, please submit a signed copy of the Acknowledgment by
 Company form with your product submittal.

Depending on the material, test samples may be required to obtain a producer/supplier number. Please contact Michael Aldridge at (217)-588-2091 for sample size as sizes vary depending on the material type. The sample and certification shall be sent to:

Any sample provided without the required information listed will not be tested. Any changes outside the manufacturer's original parameters will necessitate a new sample submittal.

Submitted materials will be tested according to the Department's current edition of the <u>Standard Specifications for Road and Bridge Construction</u>.

C. Certification/Recertification

Welded Wire Reinforcement/Bar Mat manufacturers are certified/recertified in accordance with Policy Memorandum 23-08.
